## **US Standard Limited Warranty**

### **1. Limited 3 Year Warranty**

MottAudio LLC warrants that new Guardian Audio<sup>®</sup> products manufactured by MottAudio LLC and sold in the continental United States shall be free from defects in material and workmanship for three (3) years from the date of sale to the original purchaser. This warranty is not transferrable. If any such product is defective, malfunctions or fails to conform to this written Limited Warranty under normal use and service in the continental United States, and if the original purchaser complies with Paragraphs 4 and 5 of this Limited Warranty, MottAudio LLC will either repair or replace, at our discretion, the defective product. If we elect to replace the defective product, the replacement may be a reconditioned unit.

### **2. Products Covered, Exclusions and Limitations**

This Limited Warranty shall include all new Guardian Audio<sup>®</sup> electronics and speakers manufactured by MottAudio LLC, sold through an authorized Guardian Audio<sup>®</sup> and operated in the continental United States. This Limited Warranty shall not include Guardian Audio<sup>®</sup> accessories, product with an altered or invalid serial number, or any product that MottAudio LLC has determined to have been modified, misused or abused in any way, nor shall MottAudio LLC be liable for damages or malfunction resulting from accident, misuse, negligence, installation, alterations, any act of God, or repairs not authorized by MottAudio LLC. This warranty shall not be valid outside the continental United States.

### **4. Condition Of Enforcement Of This Limited Warranty**

As a condition of enforcement of this Limited Warranty, the original purchaser must provide a copy of the original purchase receipt of the Guardian Audio<sup>®</sup> product purchased from an Authorized Guardian<sup>®</sup> Audio Dealer. The receipt must include the name, address, and phone number of the person who purchased the product, must have the purchase date, model and serial number and purchase price of the product. The receipt must also include the Authorized Guardian Audio<sup>®</sup> Dealer's name, address and phone number.

### **5. Enforcement Of Limited Warranty**

Any defective Guardian Audio<sup>®</sup> product shall be repaired or replaced pursuant to Paragraph 1 of this Limited Warranty by returning said product with prior return authorization and all shipping charges prepaid, to any authorized Guardian Audio<sup>®</sup> service center. You may also contact MottAudio LLC directly for instructions for returning the defective product for repair or replacement.

### **6. Implied Warranties Limited: Consequential Damages Excluded**

Any implied warranty in connection with any Guardian Audio<sup>®</sup> product is limited in duration to the period of this Limited Warranty. MottAudio LLC shall not be responsible for, nor does this Limited Warranty extend to consequential damage or incidental damages or expenses, including, without limitation, injury to persons or property, loss of use, inconvenience, lost profits, loss of income or any damage to other equipment, items or property on premises where product is stored or operated.

### **7. Acceptance**

Purchase of any Guardian Audio<sup>®</sup> products or services shall constitute acceptance of the conditions of this warranty and all of the specifications for such items.

### **8. No Other Warranties Made**

This Limited Warranty is in lieu of all other express warranties, and does not assume, nor does it authorize any person to assume on its behalf, any other obligation or liability.

This Limited Warranty gives you specific legal rights. You may also have other rights which vary from by state. This Limited Warranty is subject to change without prior notice.
